LW 20001671 <i>Counterfeiting / Forgery / Using / Uttering</i>	On 07/18/2020, a counterfeit \$50 bill (US currency) was attempted to be passed in the 2800 block of Schofield Avenue in the Village of Weston. This case is considered closed.
