Case #	Description	(A)ttempted, (C)ompleted, (F)elony, (M)isdemeanor
LW 20002522 <i>Crash Tpd</i>	On 10-23-2020 I was dispatched to the 3000 block for a traffic crash. I completed a crash report. A citation for no insurance was issued.	
LW 20002524 <i>Crash Tpd</i>	On 10/23/2020 it was reported a two vehicle property damage only crash occurred near Schofield Avenue and Camp Philips Road in the Village of Weston. There were no injuries and minor damage to one vehicle.	
LW 20002535 <i>All Other Offenses</i>	On 10/23/2020 it was reported two juvenile males were mentally and physically abused in previous events in the Village of Weston. A report was completed and will be forwarded to child protective services for review.

LW 20002533 <i>Crash Tpd</i>	On 10/24/20 at approximately 11: 59 am, a two vehicle crash occurred at the intersection of Schofield Avenue and Birch Street. This case is inactive.	
LW 20002549 <i>Burglary/breaking & Entering</i>	On 10/24/2020 it was reported around \$200.00 was stolen from a residence near the 200 block of Grand Avenue in the city of Schofield. This case is considered unfounded as the victim was unwilling to share information regarding the incident and demanded officers leave the scene.

LW 20002555 <i>Assault - Aggravated</i>	On 10-25-2020, a complaint involving a weapons offense that occurred on 08-02-2020 in the 300 Block of Ross Avenue was investigated. Case is currently closed based on information received.

The suspect was referred to the Marathon County District Attorney's Office for Operating Motor Vehicle Without Owner Consent after taking a vehicle that did not belong to them.
